- Treasurer-Elect: Serving as Treasurer-Elect will help increase communication and interpersonal skills with a vast array of professions from dietitians, bankers, lobbyists and other medical providers that support our profession The term is a 2-year commitment: 1-year Treasurer-Elect, 1-year Treasurer. You'll be given the chance to network with other dietitians nationwide and throughout the state and learn how our finances are spent and how NDAND gives back to our profession, locally and nationally.
- Secretary: Serving as Secretary provides an opportunity to improve communication and
 organizational skills and increases your understanding and familiarity with board
 operations, Robert's Rules, and components of a successful board. The term is a
 two-year commitment. The position allows for the flexibility to serve NDAND in different
 ways, including volunteering for different committees such as financial auditing, strategic
 planning, and more.
- Nominating Committee Chair-Elect: Serving as Nominating Committee Chair-Elect allows you the chance to become involved and familiar with the North Dakota Academy of Nutrition and Dietetics board and positions. The term is a 2-year commitment: 1-year Nominating Committee Chair-Elect, 1-year Nominating Committee Chair. You will develop skills in volunteer recruitment and build connections with NDAND members across North Dakota.
- Delegate: Serving as the Delegate allows the opportunity to be the voice for the
 membership of the North Dakota Academy of Nutrition and Dietetics at a national level.
 You'll gain the chance to not only serve your peers but also develop a national network
 which can enhance any potential career path. The term is a 3-year commitment and

does require being a participative member of the Academy for at least 3 consecutive years immediately prior to serving.

Member Updates and Professional Development

Feedback Requested: ACEND 2022 Accreditation Standards

The Accreditation Council for Education in Nutrition and Dietetics Standards Committee is conducting a survey to gather feedback regarding the current 2022 and Future Education Model ACEND Accreditation Standards for nutrition and dietetics education programs. Per United States Department of Education requirements, the ACEND Accreditation Standards are revised every five years. The results of this survey will be used to revise the 2022 and FEM Standards.

Your feedback will be critically important as the 2027 Standards are being developed. Note that there are two surveys, one for the 2022/FEM Standards and Required Elements and another related to the Knowledge, Competencies and Performance Indicators. The Standards survey may take 40 to 60 minutes to complete; the review of the Knowledge, Competencies, and Performance Indicators may take up to two hours to complete. You can stop the questionnaire and re-enter at a later time to finish your responses.




4th Annual "A Taste of Culinary Nutrition From Around the Globe

This symposium, "Gut Health Reflections"


Part 2, is our largest CEU offering of the year,

The Academy thanks U.S. Sens. Susan Collins (Maine) and Gary Peters (Mich.) and U.S. Reps. Robin Kelly (III.) and Jen Kiggans (Va.) for introducing the Medical Nutrition

Therapy Act of 2023.
